



**Notification 002/2019 Enlistment/ Registration of
Engineering/ Architectural Institutions for
appraisal and certifying quality standards**



Andhra Pradesh Real Estate Regulatory Authority (APRERA) was constituted under the Real Estate (Regulation & Development) Act, 2016, with an objective to regulate and develop the Real Estate and Construction Industry in Andhra Pradesh State and inter-alia to educate and protect the interests of the consumer and bring technological improvement in construction and Building material industry.

As per the provisions of the act, all Real Estate Projects being/ to be executed in the A.P. State have to register with the Authority.

The registration process includes, among several articles, verification of the sufficiency of structural stability, Performance of MEP Systems, environmental issues, workmanship and quality of building material.

A.P. RERA invites applications from Engineering/ Architectural Institutions, situated in state of A.P. to send their Expressions to undertake such assignments for appraisal and certifying quality standards.

The shortlisted Institutions would be required to develop a Cadre of independent appraisal experts, who would be trained by them and certified for their skills.
