ORDER:

In the reference 1st read above, the Government of India has enacted “The Real Estate (Regulation and Development) Act, 2016 and published in the Extraordinary Gazette No.16 of 2016, dated 25th March, 2016. According to timelines specified in the Act, the appropriate Government is required to notify making the Rules and establishment of regulatory authorities and Appellate Tribunals within one year of the commencement of Act.

2. Accordingly, in the reference 2nd read above, Government have issued orders for formulation the “Real Estate (Regulation and Development) Rules, 2017”. Under Rule-18 of Real Estate (Regulation and Development) Rules, 2017, the procedure for constitution of “Real Estate Regulatory Authority” and the manner of selection of Chairperson and Members of the Authority is prescribed.

3. Government, after careful examination, hereby appoint the Search Committee with the following officers to finalize a panel of suitable persons and forward the same to the Selection Committee as per (5) (b) of Rule 18 of Real Estate Regulation Act Rules, 2017:-

1. Sri S.P Tucker, I.A.S., Chief Secretary to Government (Retd) : Chairman
2. Dr. Manmohan Singh, I.A.S., Special Chief Secretary, A.H. D.D. & F. Department : Member
3. Sri J.C Sharma, I.A.S., Special Chief Secretary, Revenue Department : Member

4. The search committee shall prepare a panel of eligible candidates for the positions of Chairperson and three members and forward the same to the Selection Committee within 15 days and thereupon the Selection Committee will do the selection and recommend to the Government within 15 days.
